

## **SUMMARY NOTICE**

### **STEVEN D. MARCRUM VS. HOBBY LOBBY STORES, INC.**

#### **NOTICE OF PROPOSED CLASS ACTION SETTLEMENT YOUR LEGAL RIGHTS MIGHT BE AFFECTED BY THIS SETTLEMENT PLEASE READ CAREFULLY**

You may be a member of class in a case that has been preliminarily approved for a class action settlement. The case is listed above and is pending in the United States District Court for the Northern District of Alabama, Southern Division (Civil Action No. 2:18-cv-01645-JHE). The class action lawsuit above was filed on behalf of customers against Hobby Lobby Stores, Inc. It alleges that Hobby Lobby's stores in Florida violated Florida law with respect to application of their 40% discount coupon with furniture purchases that occurred between June 4, 2014 and October 2, 2017. The claim is that Hobby Lobby did not give the proper amount of the discount that the Plaintiffs assert should have been given. Hobby Lobby denies all allegations in the lawsuit, and further contends that it provided the correct amount of coupon discount savings and that all of its practices conformed to Florida law.

#### **How Do I Know If I Am Part Of The Settlement?**

The Court has preliminarily determined that everyone who fits the following description is a class member: All persons or entities who purchased furniture at a Hobby Lobby store in Florida between the dates of June 4, 2014 and October 2, 2017, and in connection with that purchase, used a Hobby Lobby 40% discount coupon.

Excluded from the Settlement Class are those persons or entities (a) who had claims pending against Hobby Lobby before either a federal or state court as of the date of Preliminary Approval, where those claims related in any way to the Hobby Lobby 40% coupon; (b) who previously released all claims against Hobby Lobby; (c) who had previously settled any claims they pursued (or could have pursued) against Hobby Lobby, where the suits or claims were independent and unconnected to any Settlement Agreement reached in this case; or (d) who are Hobby Lobby agents or employees, or are family members of Hobby Lobby agents or employees, or who are otherwise affiliated with Hobby Lobby.

### **What Does The Settlement Provide?**

If the settlement is approved, you are eligible to receive \$14.00. But to receive these benefits, you must complete a Settlement Claim Form requiring you to provide certain information about your furniture purchase at Hobby Lobby.

### **What Are My Options?**

You can get out of the settlement. To exclude yourself from this Settlement, you must submit a request for exclusion to the Settlement Administrator. You can learn more about what you must do to exclude

yourself by visiting [www.hobbylobbysettlement.com](http://www.hobbylobbysettlement.com) or by calling the Settlement Administrator toll-free at 1-833-667-1232. If you do not exclude yourself from the Settlement, you will remain a Class Member and may be eligible to claim settlement benefits at a later time.

If you do not exclude yourself from the Settlement, you can object to the settlement. To object to this settlement you must file a written objection by July 6, 2021, and you may (but are not required to) appear through counsel if you wish to do so. The exact procedures for objecting and appearing at the hearing are provided at [www.hobbylobbysettlement.com](http://www.hobbylobbysettlement.com), or may be obtained by calling the settlement administrator at 1-833-667-1232.

If you remain in the settlement and it is approved, any claim you may have against Hobby Lobby regarding the conduct at issue in the lawsuit will be discharged and released.
